Injuries received from others, including my guide, using fishing equipment 5. Injuries received from

encounters with wildlife and/or insects 6. Injuries received from exposure to the sun, lighting, wind,

weather, and elements 7. The absence of rapid medical attention/emergency response I understand the

risks, hazards, and dangers of fishing and have had the opportunity to discuss them with a representative

of Salty Dawg Guide Service. I understand that these activities may require good physical conditioning

and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of

skill and knowledge necessary for me to engage in these activities safely. I understand that I have

responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and

I elect to participate in spite of the risks.
